Greetings friends and neighbors from our Alder

As you can probably imagine, I have been receiving a much higher number of contacts from my friends, neighbors, and constituents regarding issues and problems in our neighborhood. This morning I received a phone call from one of my Tamarack neighbors about excessive speeds and reckless driving on Tree Lane. She suggested that traffic enforcement and possibly 'speed humps' might be appropriate remedies. Both are good ideas, and I will be forwarding them on to staff for their consideration and action.

Vista West Senior Housing

We have a new neighbor. Capri Communities has finalized the purchase of their lot next to Tamarack on the east end of Tree Lane. Vista West will join a portfolio of over 20 senior communities primarily in Milwaukee and Waukesha. In addition, they have facilities in Sun Prairie and Cottage Grove.

They have started construction of their senior housing project. The building will include 174 apartments for independent living, assisted living and memory care residents.

The Stevens construction fence is in place and their job trailer is on site, along with some large earth-moving equipment. Construction is expected to take 15 months

A short period of controlled blasting will take place at the end of June and early July to break up sections of bedrock. It blasting is needed mid-site to create and area to accommodate the underground parking and some of the stormwater holding tanks.

The area along our property line will be re-landscaped. All of the trees that were scheduled for removal have been taken down.

Capri is scheduling a virtual public information meeting on Wednesday, June 24th at 5:30pm which is open to all Tamarack residents and neighbors. An invitation was emailed to you.

Board and Committee Business

Architectural Review Board

Dear Neighbors, A reminder from the ARB regarding changes to your units:

Be aware that some alterations to your exterior (done with approval from ARB, of course) may require the unit owner to incur additional costs for repairs/ maintenance made necessary by the alteration if the change increases the cost to maintain or repair that item. Tamarack will be responsible for the usual costs, but not responsible for additional costs.

An example might be leaks or regular roofing shingle maintenance altered by solar tubes or solar panels which alter the integrity of the original design/ application

This is also an important item to disclose in the case of selling or buying a unit.

Finance Committee Update

Although we took a pass for our March meeting, the Finance Committee did meet in April and May using virtual meeting and conference call software. Given concerns regarding the US economy, it is important that we stay on top of the status of TT's finances, in particular the Investment Fund which is managed for us by US Bank. Although the fund experienced declines in the early months of the COVID-19 pandemic, we are pleased to report that, as of mid-May, the balance in the fund was \$521,352. The goal we set for the fund at the close of the 2020 fiscal year (end of December 2020) is \$520,000. So, although we anticipate further fluctuations in the fund, we feel hopeful that our goal will be achieved.

There were excess funds remaining at the close of 2019 as not all the work that was budgeted for was completed last year. As a result, we have added additional funds to the 2020 Budget, including the Drainage account as it is anticipated that drainage problems throughout the property will be costly to remedy. We also added \$5,000 to hire professionals to assess the remaining life of both the pool and unit roofs. The report we received from the Reserve Advisors study of our property specified replacement dates for the pool and roofs that differ from the dates used in TT's Long-Range Budget. Additional opinions are needed so the dates for this work as depicted in the Long-Range Budget are as accurate as possible. Finally, we have set aside some funds that can be used to shore up the Investment Fund should our goal of \$520,000 not be met.

Our committee has received significant help from Don Haasl and Larry White who have worked long and hard to update our Long-Range Budget (30-year). It now incorporates recommendations made by Reserve Advisors as well as the account numbers used in Appfolio, our current accounting software.

The financial audit of our books is set to begin this month and in July we will kick-off the 2021 budget development process. We have a committee composed of responsible members who are diligent in attending to TT's financial matters, including making recommendations to the Board. Thanks go to Tom Ferris, Don Haasl, George Meyer (Board Treasurer), Gordon Renschler, James Steinbach, Deni Tucker, Janet Zimmerman and Prudy Stewart (Committee Chair).

Welcoming Committee

Q.: I'm new to Tamarack Trails (TT). Do I have to consult with anyone before making changes to the exterior of my unit?

Yes, and thanks for asking. You need to submit proposed changes to your unit's exterior to the TT Architectural Review Board (ARB) for approval. Standards that regulate the external appearance of TT structures and common areas have been developed over time by the ARB and the Board of Directors with input from countless property owners. The ARB reviews proposed exterior changes to ensure that they meet these Standards.

Examples of changes that require review include unit additions, windows and awnings, skylights and solar tubes, doors, fences and screens, decks and railings, screened porches, patios, and landscaping.

Before making changes, complete a *Check List of Items for Requesting Exterior Alterations or New Construction* and submit it to the TT Association Office at least 14 days before the next regularly scheduled ARB meeting. You may also submit a request online via your AppFolio portal.

The *Check List* form and TT architectural standards can be found in the *ARB Book of Standards*. This document is available online at <u>www.tamaracktrails.com</u> or from the office.
