III. Association Manager's Report – Stacey Haberman

Swimming pool

- Concrete pours are complete, wave line is currently being installed
- Removal of pool decking will start soon
- Tile colors selected for pool by community are in clubhouse lobby for viewing

- Replacing entire rim joist and sill plate on a foundation (2 homes)
- Removing and replacing damaged light posts / electrical wire replacing
- Replacing ground breaker on foundations

- Working with contractor on concrete replacements

 - MOTION: Approve transfer of \$132,000 in operating funds in Edward Jones money market account plus additional \$18,000 in operating cash from operating fund to reserve fund. GJ/DL – PASSED
 - 3. **MOTION**: Approve financing recent bill for \$615,692.15 from Badger SwimPools using Edward Jones investments plus operating cash transferred from operating fund. **GJ/DL PASSED**
 - 4. **MOTION**: Approve transfer of \$5,700 in Workers' Compensation refunds received thus far in 2024 to Contingency Fund. **GJ/JM PASSED**
 - 5. **MOTION**: Approve increase in cost per hour for construction and remodeling work performed by Maintenance staff from \$50.00 to \$75.00 and from \$50.00 to \$60.00 for work done by Grounds staff effective October 1st. **DL/GJ PASSED**
 - 6. Budget Hearing will be held October 10th. Draft budget represents overall 5.3% AMA increase.
