III. **Solar Panel Project for Clubhouse**

A. Meyer reported that this project is postponed. The timeline of this project was based on the belief that Tamarack would have a large capital gains tax due in 2026 which could be offset by a solar panel tax credit. Following a conversation with the bank handling the pool loan, it was determined that our capital gains and, subsequently, our tax liability would be much smaller. This would eliminate the solar credit which was being used to finance the project.
